THE PUMP TRUCK WAS CONNECTED DIRECTLY TO THE 2" CASING. COTTON SEED HULLS WERE MIXED WITH THE FIRST OF THE CEMENT TO BE PUMPED. CEMENT WAS PUMPED INTO THE CASING UNTIL THE WELL WOULD HOLD PRESSURE. THE WELL WAS THEN SHUT IN AT 700 PSI. 31 SACKS OF CEMENT WERE PUMPED INTO THIS WELL
