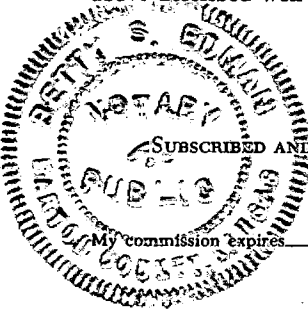
Measured into TD 3430'.
