THIS WELL CONSISTED OF 5.187 CASING TO 868' THAT HAD BEEN CEMENTED IN FROM BOTTOM TO TOP. 3 1/2" TUBING ON A PACKER WAS STUCK IN THE WELL FROM SURFACE TO 854'. THE 3 1/2" TUBING WAS PERFORATED FROM 843' TO 844'. 1" PIPE WAS RAN INTO THE WELL TO 904'. CEMENT WAS PUMPED INTO THE 1" PIPE UNTIL CEMENT CIRCULATED FROM THE WELL AT SURFACE BOTH INSIDE AND OUTSIDE THE 3 1/2" TUBING. THE 1" PIPE WAS REMOVED. DISPLACEMENT WAS FILLED FROM SURFACE. THE WELL WAS THEN SQUEEZED AND SHUT IN.
