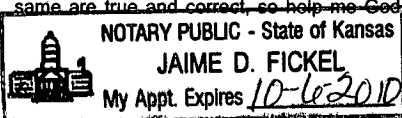

THE PUMP TRUCK WAS CONNECTED DIRECTLY TO THE 4 1/2" CASING. COTTON SEED HULLS WERE MIXED WITH THE FIRST OF THE CEMENT TO BE PUMPED.
CEMENT WAS PUMPED INTO THE 4 1/2" CASING UNTIL THE WELL WOULD HOLD PRESSURE. THE WELL WAS THEN SHUT IN AT 700 PSI., 70 SACKS
OF CEMENT WERE PUMPED INTO THE WELL.
