CEMENT WAS PUMPED INTO THE 4 1/2" CASING UNTIL THE WELL WOULD HOLD PRESSURE. THE WELL WAS THEN SHUT IN AT 800 PSI., 85 SACKS
OF CEMENT WERE PUMPED INTO THE WELL.
