 It is agreed that the following minimum requirements will be met:

**DEC 17 2008**

1. Notify the appropriate district office **prior** to spudding of well;
2. A copy of the approved notice of intent to drill **shall be** posted on each drilling rig;
3. The minimum amount of surface pipe as specified below **shall be set** by circulating cement to the top; in all cases surface pipe **shall be set** through all unconsolidated materials plus a minimum of 20 feet into the underlying formation.
4. If the well is dry hole, an agreement between the operator and the district office on plug length and placement is necessary **prior to plugging**;
5. The appropriate district office will be notified before well is either plugged or production casing is cemented in;
6. If an ALTERNATE II COMPLETION, production pipe shall be cemented from below any usable water to surface within **120 DAYS** of spud date. Or pursuant to Appendix "B" - Eastern Kansas surface casing order #133,891-C, which applies to the KCC District 3 area, alternate II cementing must be completed within 30 days of the spud date or the well shall be plugged. **In all cases, NOTIFY district office** prior to any cementing.

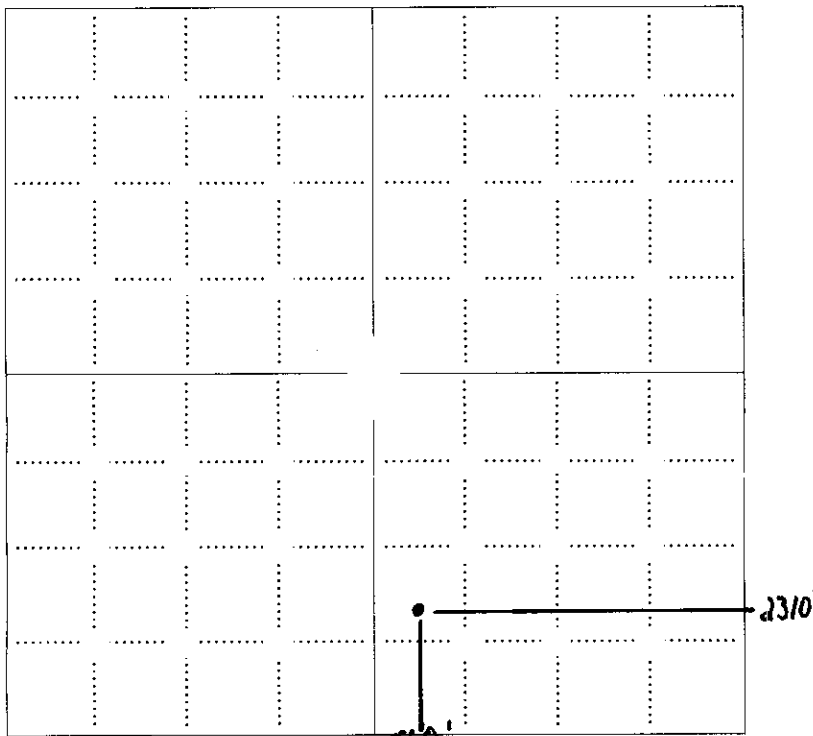

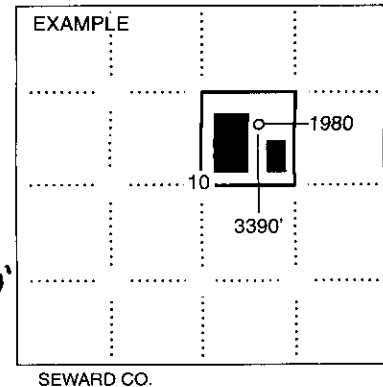

## NOTICE TO OPERATORS

Do not spud this well until proper notification has been made to the Kansas Corporation Commission's District Office. The operator to whom the KCC drilling permit has been issued is primarily responsible for making the required notification. In the event the required notification is not received by the appropriate district office, the responsible party(ies) may be assessed a monetary penalty for violating K.A.R. 82-3-103(b). That KCC regulation states:

*K.A.R. 82-3-103(b) District office notification.*

*Prior to spudding the well, the operator shall notify the appropriate district office. Failure to notify the appropriate district office before spudding the well shall be punished by a penalty of not less than \$250 and not more than \$1000.*

The appropriate District Office for the attached drilling permit is the KCC Dodge City District Office. Notification can be made to the KCC Dodge City District Office Monday through Friday from 8:00 AM to 5:00 PM at 620-225-8888. If the well is to be spudded over the weekend, the spud call should be given before 5:00 PM on Friday. If the well is to be spudded on a holiday that results in the closure of state agencies for that holiday, then the spud call should be given before that holiday.
