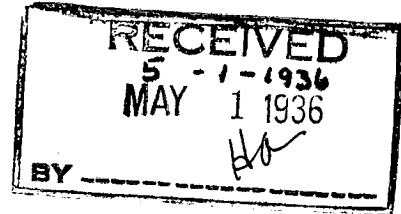

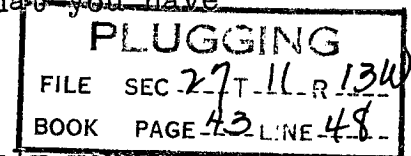
Confirming telephone conversation of Mr J.M. Dunn of the Bridgeport Machine Co. and your self this morning we are writing you for permission to plug the following well.
