The Dakota Sand, from 1740' to 1930' broke in late in September, 1977, and on October 12, 1977, the leak in the casing at 1735' was squeezed by Halliburton with 300 sacks of 60-40 Posmix, no gel, containing 1% calcium chloride.

My operator's license number is #6639.

Field name is questionable. In one place I find it to be Hoeting and in another I find it to be Glendale.
