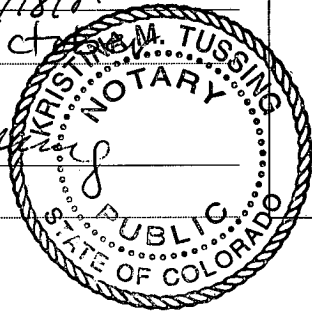

REMARKS: Rig up to 4 1/2" casing, Break circulation with 10 Bbl water, 5 Bbl. Gel Flush, followed with 15 Bbl water spacer, Mixed 65 SKs. Quick Set cement w/ 4" P²/SK of KOI-SEAL at 13.8 lb. P²/GAL. Shut down - wash out pump & lines - Release Plug - Displace Plug w/ 8 Bbls water. Final Pumping at 300 PSI - Bumped Plug to 1000 PSI - wait 2 minutes - Release Pressure. Float Held - close casing in w/ 0 PSI - Good cement returns to surface w/ 4 Bbl slurry.
