Sanded off bottom, loaded hole with water, dug cellar, unpacked casing head, set floor, checked hole, sand was at 5100', bailed 4 sacks cement with bailer, pulled slips, cut surface off 4' below ground, had 22" stretch, ripped casing at 3000', pipe came free, pulled casing up to 1070', pumped 12 gel, 50 sacks, 100# hulls, pulled to 600', pumped 50 sacks, 100# hulls, pulled to 40', pumped 20 sacks to surface, tore down floor and rig, emptied pit.
