Mixed 140 sks thickset cement w/ 5# Kd-seal 5015/100 @ 13.4 #/gal. Washout pump + lines shut down. release plug. Displace w/ 21 Bbl fresh water. Final pump pressure 600 PSI. Bump plug to 1100 PSI. Wait 2 mins release pressure float hold. Good cement returns to surface = 8 Bbl slurry to pit. Job complete. Rig down.
