Mixed 135 SKS thickset cement w/ 5# Kol-seal @ 13.2# gal. Washout pump + lines, release plug. Displace w/ 20.0 Bbl fresh water. Final pump pressure 600 PSI. Bump plug to 1100 PSI. wait 2 minutes release pressure. Float held. Good cement returns to surface = 7 Bbl slurry to pit. Job complete. Rig down.
