Pulled tubing to 700', mixed 50 sacks cement. Pulled tubing to 260', mixed 40 sacks cement and circulated to surface shut in 6" casing, mixed 25 sacks cement. Didn't come around. Pulled tubing, hooked on annulas, mixed 6 sacks cement. Pressured up to 300#. Topped of with 20 sacks cement. Plugging Complete
