Pulled drill pipe to 710' and Allied Cementing mixed and pumped 50 sacks of 60/40 poz 4% gel as a balanced plug. Pulled drill pipe to 250' and Allied Cementing mixed and pumped 50 sacks of 60/40 poz 4% gel as a balanced plug. Pulled drill pipe to 60' and Allied Cementing mixed and pumped 20 sacks of 60/40 poz 4% gel as a balanced plug. Allied mixed and pumped 30 sacks of 60/40 poz 4% gel down rathole. Well plugged.
