Dumped sand to 3075' and 4 sacks cement. Shot casing at 2700', 2500 and 2250'. Pulled 52 joints of 4-1/2" casing. Squeezed well with 4 sacks hulls, 10 sacks gel, 1/2 sack hulls, 30 sacks cement, 12 sacks gel, 1/2 sack hulls, released plug and pumped 140 sacks 60/40 pozmix cement with 6% added gel and 3% calcium chloride. Maximum pressure was 700 psi and shutin 700 psi.
