Pulled drill pipe to 600' and Allied Cementing mixed and pumped 70 sacks of 60/40 poz 4% gel as a balanced plug. Pulled drill pipe to 240' and Allied Cementing mixed and pumped 50 sacks of 60/40 poz 4% gel as a balanced plug. Pulled drill pipe to 60' and Allied Cementing mixed and pumped 20 sacks of 60/40 poz 4% gel as a balanced plug. Allied mixed and pumped 15 sacks of 60/40 poz 4% gel down rathole. Allied mixed and pumped 10 sacks of 60/40 poz 4% gel down mousehole. Well plugged.
