Mixed and pumped 50 sx 60/40 Pozmix cement w/ 4% gel and 150# of hulls down tubing. Pulled up to 3000'. Mixed and pumped 100 sx 60/40 Pozmix cement w/ 4% Gel, down tubing; cement circulated to surface. Pulled remainder of tubing out of hole. Mixed and pumped 15 sx 60/40 Pozmix cement w/ 4% Gel, down casing, remained full. Unable to pump cement down 8.625" surface casing; instantly pressured to 100#. Plugging complete at 12:15 p.m.; approved by Marvin Mills with the KCC.
