H-D Oil Field Service, sanded off bottom with 10 sacks of sand and rigged up pulling unit and pulled stretch on 5.5" casing. Perf-Tech Wireline Service, dump bailed 4 sacks of cement on top sand at a PBSD of 4240'. Perf-Tech shot off casing @ 776'. H-D pulled casing to 725' and Swift Services pumped 80 sacks of 60/40 poz, 4% gel and set balanced plug @ 725', H-D pull casing to 260' and Swift Services pumped 50 sacks of 60/40 poz, 4% gel and set balanced plug @ 200', H-D pull rest of casing and Swift Services top off 8 5/8" casing with 30 sacks of 60/40 poz, 4% gel. Well plugged.
