The Above well was plugged as follows:

260'--8 5/8" Surface pipe, cement circulated.  
3761'--4 1/2" Production casing cemented with plug stopped @ 3730' Drilled out cement and found well to have been drilled 28' deeper than originally reported. Well abandoned.

Sanded well back to 3700' and set 5 Sx. cement with dump bailer. Pulled 4 1/2", well left full of good rotary mud. Ran 2 1/2" tubing to 550' and displaced 20 Sx. cement thru 2 1/2". Pulled tubing to 250' and displaced 20 Sx. cement thru 2 1/2". Well left as potential water well at request of land owner. (Authorization attached). (Recovered appr. 3200' 4 1/2" casing).
