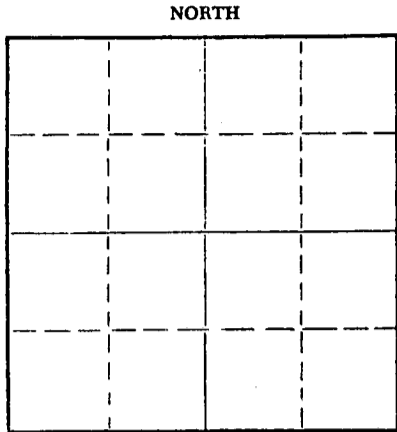

Allied Cementing Co. pumped 4 sx. hulls- 15 sx. gel 100 sx. cement, 13 sx. gel & 70 sx. cement

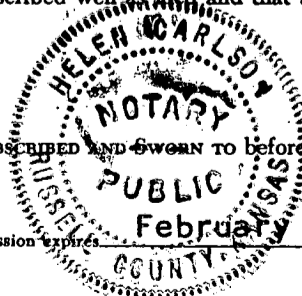
