Pulled tubing to 1632' & spotted 35 sacks 60/40 w/4% gel. Perforated casing @ 250'. Pulled tubing to 253'. Mixed 50 sacks 60/40 w/4% gel & circulated cement to surface in casing. Shut casing in @ head. Mixed 100 sacks 60/40 w/4% gel & circulated cement to surface up annulus. Pulled tubing & topped w/10 sacks 60/40 w/4% gel. Job complete. R.D.M.O. State man on location - Shane Jones.
