This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Bartlett 1well.

The original 365 days for closure expired March 28, 2009. This extension will expire March 3, 2010. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(a). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

Dear Jonelle:

As per your request during our phone conversation, this letter is to inform you that the drilling pits are not closed and we are requesting an extension of time for 6 months.

The Bartlett Lease pits are surrounded by corn and the lease owner – Andra Bartlett has requested that we wait until after crop has been harvested before continuing the closure and surface restoration work. So far we have spent 17 hours and \$2,395.00 on this lease restoration. Drilling site has been leveled and pits have been crowded and slotted on three sides. Theis Dozer Service, Inc. of Kingman, Kansas is our dirt work contractor. It is important that pits be dry before filling and the rains just keeps coming – 3.7 inches on 8/19/09 in this area.

We will continue to diligently work on the closure of these pits.
