Dear Mr. Jervis:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Dunbar B 1 well.

The original 365 days for closure expired April 29, 2009. This extension will expire January 28, 2010. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(a). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

Several months ago we asked for an extension for backfilling the pits on the above-caption well and it was granted. This extension expires on July 29, 2009. We cut the dike and have pushed these pits several times. The landowner asked us to stop until he harvested his wheat last month. He has done so but, according to him, the pits are still too wet to finish at this time. I visited with him two days ago and between the two of us we will either pump out some of the water or push the pits. Either way, we will not have them closed by our extension deadline of July 29th so we are therefore requesting another 3-moths extension in order to complete this job.
