Dear Mr. Callewaert:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Demel 1-28 well.

The original 365 days for closure expired July 6, 2008. This extension will expire June 1, 2009. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(a). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

Please accept my apologies for allowing time to close the pit on this hole to expire without closure or an application for another extension of time. The working pits and fresh water pit have been closed and the reserve pit has been partially closed but not completely closed yet. There is still some water in one corner that needs to dry. The contractor we have hired to do this work, Langfeld Dirt Service inspected this pit on November 25, 2008 with the hope of finishing this work.
