Dear Sir or Madam:

This letter is to inform you that you have been granted an additional extension of time in which to close the drilling pits associated with the drilling of the NORDHUS-DROUHARD 2 well.

The original 365 days for closure expired 01/12/2007. This extension will expire 08/10/2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the closure of surface pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

Mr. Louis/Ms. Rains:

We have appropriately monitored the subject pits through the winter months and as of March 26th, 2008 with the field assistance of Mr. Steve VanGieson (District #2) we have concluded that this particular location continues to need more cooperative weather assistance in order to effectively complete its closure.

The ground and underground surface moisture of the subject location contains a much higher water saturation than the other two (2) locations that had been drilled on said property by us, backfilled and surface successfully restored.


Additional fresh rain (water) fluids have recently re-entered these pits from the previous weeks of thunderstorm, rain related weather.

In our conversation with Mr. VanGieson, he mentioned that the time frame may be best to our advantage if done in the August month. To our knowledge, he was going to make notation of that along with his inspection and this matter to District #2.

Please allow this letter to represent our request of extension for closure of the subject pits, the CPD-4 filing and for your (KCC) consideration to this matter.
