Dear Ms. Hundley-Goff:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Euhus Trust 1-28 well.

The original 365 days for closure expired November 7, 2007. This extension will expire April 24, 2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

## Dear Sammy:

I spoke with Kathy of your office this morning about the pit closures on the captioned wells and she told me to write this letter to you. In 11/07, I fax'd requests to you requesting 30 day extensions for pit closure on both the captioned wells (the original 365 days for pit closure expired 11/17/2007 for the Marvin May and 11/7/07 for the Euhus Trust). At the time of the 11/07 request, I was assured by my contractor, Brooks Construction in Bartley, NB, that he could meet the extension deadline. I did not follow up with him, assuming the pits had been closed, and when I did not receive an invoice from him by years end I phoned him. He told me his "weather window" to close the pits was too short and they had not been closed and now we would have to wait again. The contractor spoke with Darryl Ditmer of the District 4 office today, and Darryl told him it was no problem and to get the pits closed as soon as weather permitted. I spoke with Darryl today to let him know we are requesting another extension. He said the conditions are bad and we will have to wait. I told him I would call him every now and then to get his assessment of the conditions. We have received no complaints from the landowners.

I am requesting a 90 day extension for both wells (since 30 days has already elapsed since the end of the last extensions). This time I will call the contractor on a regular basis to make sure he is checking the locations so he can get them closed.

I apologize for all the delays. Thank you for your time and please do not hesitate to call with any questions.
