Dear Mr. Hutchinson:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Bookstore 1-25 well.

The original 365 days for closure expired August 17, 2007. This extension will expire March 19, 2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.



Jonelle:

I am aware that our (90) day extension on closure of our drilling pits will expire on the 17th of November, 2007. We have dewatered on the 18th of October and have crowded pits on the 24th of October. We are planning to crowd the pits on the 13th of November, but I don't believe that the closure can be completed. The other problem that we are faced with is that the irrigation system has been running on a daily basis, since wheat was planted the later part of September.

If the backfilling can't be completed by the 17th of November a second extension will be necessary. I think with an additional (60) days extension that the closure could be completed.
