This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Taylor 1 well.

The original 365 days for closure expired February 12, 2007 This extension will expire July 23, 2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

Dear Sir/Madam:

I took over operations of the above referenced well from Lotus Operating Company last August. Lotus had received an extension of time to close the drilling pits that is due to expire January 16, 2008.

I am asking for another extension since I will be unable to close the pits by January 16. The pits are located in a very low area and collects water from rain and the irrigation system. On a couple of occasions just prior to the end of the irrigation season, the irrigation system stopped just short of the pits during the night but continued to pump water for hours, much of it draining into the pits. This plus several rains left the pits nearly full of water. I contracted Great Plains Fluid Services to empty the pits in October, but due to a miscommunication they did not start until November. They were only able to haul 560 bbls. before several rains in November and December made it impossible to get their trucks close enough to the pits. They have been instructed to finish the job as soon as they can get their trucks on site.

I will make every effort to have the pits closed as soon as possible.
