This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Mogan 1-36 well.

In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. 

Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.
