Dear Mr. Kirmer:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Peterman 3 B well.

The original 365 days for closure expired December 16, 2007. This extension will expire July 26, 2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

This letter is to inform you that I have not been able to close the surface pit on the Peterman 3B (API # 15-053-21197-0000) due to the weather conditions that have hindered our area in 2007 and now the first four months of 2008. I realize the surface pit was to be closed by 4/16/08 but we still have not been able to get the pit dry enough to close it up. The pit is located down in a draw and has continued to be wet, even though it has been dammed up so that water could not get in it. I have also had the water hauled out of the pit on four separate occasions. Please accept this letter for an extension on the closure of the surface pit. I phoned and visited with Jonelle Rains on Monday, April 14, 2008, and she instructed me to again apply for an extension on this surface pit on the Peterman 3B.
