Dear Mr. Pride:

This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Ralph 1-7 well.

The original 365 days for closure expired April 20, 2007. This extension will expire October 12, 2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.

Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

In reference to the above well, your letter dated May 28, 2008 (copy attached), and our telephone conversation this morning, I discussed the pit closure issue with our field representative and the surface owner, Mr. Ralph Dick, and they both agree that while the pit area that needs to be closed is still wet in parts of the pit, the surface area should be dry enough to close the pits within the next 90 days. The surface owner, Mr. Ralph Dick, has the equipment to close the pit and has closed several pits in the area and desires to close this pit. Barring any additional rain, he plans to begin on the pit closure after he gets his crop harvested in a few weeks. Therefore, we cordially request a 90-day extension from today to close the subject pit.
