In reviewing the incredible information you provide regarding our operations in the state of Kansas, we have identified a few updates and/or corrections that we are requesting you authorized to be made. We have attached a spreadsheet detailing these differences between our records and the state's records as well as a well data printout from the KGS for each well. Please refer to the attached sheets for the specifics, but these are the areas we would like to review:

- 1) There are two wells we operate whose API number does not appear in the KGS database. 1517930146 (the Adell Unit 512 - Oil) and 1516301921 (the Pirotte 4 - Oil). We would appreciate you adding these wells to your database.
- 2) There are 13 wells which show the current operator as "Unavailable" and one that shows "Conoco, Inc." All 14 wells should show "Landmark Resources, Inc." as the current operator. We filed changed of operator forms either in mid-1997 (for the Vohs, Pirotte, Fehrenback, and Clancy wells) or in early 1999 (Adell Unit wells) as the purchases we finalized. We would appreciate you checking your records and making these corrections.
- 3) There are some discrepancies in well numbers in the Adell Unit and with the well name of Vohs 6 (you show Vohs 'B' 6). While we could change our records to match the name/numbers you are showing, we would prefer to have the state make changes since these are the well name/numbers we inherited upon purchase. Accordingly, we have been using those names/numbers internally and for reporting purposes for the past 10 years.
- 4) You show the Adell Unit 210 (our Adell Unit 201) as "P&A." This well was converted to a SWD.
- 5) Please correct our main phone to our Houston number: 713-243-8550

We deeply appreciate you taking the time to review and correct these discrepancies. Our desire is simply to have our information as accurate as possible. Please let us know if you require any additional information for us.
