This letter is to inform you that you have been granted an extension of time in which to close the drilling pits associated with the drilling of the Wieland Unit 4-16 well.

The original 365 days for closure expired September 5, 2007. This extension will expire May 20, 2008. We urge you to make every effort to close these pits within this time frame. In the event there is water standing in these pits, please dewater and dispose of fluids in an authorized disposal facility to expedite closure. Extension of this time frame automatically extends the time period for filing the Closure of Surface Pit form.


Failure to close the pit or request an additional extension prior to the expiration date may result in a fine in accordance with K.A.R. 82-3-602(c). An additional extension will only be granted for good cause and after K.C.C. field staff has made an inspection of the site. Should field staff discover that said pit has been closed before the date of extension request, an administrative penalty may be assessed to you through K.C.C. invoice.

Dear Commission:

Per rule K. A. R. 82-3-602(a), Citation is requesting an extension to the 365 day pit closure from spud rule in order to close the drilling pit at the Wieland Unit 4-16 well location until June 2008. I filed a letter requesting a 90 day extension December 5, 2007 in hopes that this pit would be dry enough. The extension will be up on February 15, 2008. Citation is requesting an additional extension.

The pit location for the Wieland Unit 4-16 lies in a bottom topographical area and has proven a poor area for drying. Kansas has received 15"-18" of rain, snow and cool temperatures causing the pit to not dry up enough to close it.
