Rigged up on location, layed down 131- 3/4 in singles layed down 114 joints of 2 7/8. Swabbed tubing dry. sanded bottom to 3425' and dumped 6 sacks of cement with bailer. Dug out cellar, cut hole in surface pipe, Ran 1" tubing to 350' 2" down annualas ran 2" down. 7" to 350' hooked up Copeland Cementers to 1" tubing pumped 250 sacks cement. circulated to surface. Opened up 7" and pumped 35 sacks cement. cement circulated to surface. Layed tubing down Topp off with 10 sack cement. 60/40pos 4% gel. Tore down and Moved off.
