06/23/10 - Drive to location. Rig up Log-Tech. Shot casing off @ 1658'. Rig Log-Tech down. Pull 13 jts. 1st plug @ 1110', 15 gel - 50 sacks 60/40 4%. 2nd plug 400' - 40 sacks. 3rd plug - 40' - 20 sacks. Recovered 39 jts of 5-1/2" pipe. Rack out jacks. Rig down. Clean location & tools.
