Plugged off bottom with sand to 3515' and 4 sacks cement. Perforated 4-1/2" @1300', 850' and 250'. Ran 2-3/8" tubing to 1300', pumped 35 sacks cement, pulled tubing up to 850', pumped 35 sacks cement, pulled up to 250'. pumped 110 sacks cement, didn't circulate, tagged cement @850'. Ran back in to 850', pumped 35 sacks common, pulled up to 250' and circulated 100 sacks cement to surface, 60/40 pos, 4% gel. Plugging Complete.
