Abandonment procedure of pit:

**All excess fluid was hauled off or allowed to evaporate. Pit was cut to dry. Sides were squeezed as the pit dried. Ground was worked to allow excess pit fluid to evaporate. Pit was then backfilled and surface was contoured back to original. Topsoil was replaced from topsoil stockpile and location backfill was completed.**
