Plugged off bottom with sand to 3119' and 5 sacks cement. Perforated casing @1150', 800' and 270'. Ran 2-3/8" tubing to 1150' and pumped 35 sacks cement, pulled up to 800', pumped 35 sacks cement, pulled up to 270' and circulated 50 sacks cement to surface. Layed down tubing, pumped 5 sacks cement, tied onto annulas, pumped 15 sacks cement, topped off with 20 sacks. 60/40 pos, 4% gel. Plugging Complete.
