Pump 100 sacks w/200 lbs cement. Pull up to 500'. Pump 135 sacks w/100 lb hulls. Cure up casing. Pull tubing out. Pump 20 sacks down casing. Circulated up surface. Rig over & down. Drive rig to yard. \*\*Perforated well @ 1350', 615' & 250'.
