Cut casing loose @2250', pulled up to 1500', pumped 175 sacks cement w/200# hulls, pulled up to 600', pumped 25 sacks cement, pulled up to 300' and circulated 150 sacks cement w/100# hulls to surface. Topped off with 20 sacks, 60/40 pos, 4% gel. Plugging complete.
