Ran tubing to 2996', pumped 35 sacks cement and 300# hulls, pulled up to 900', pumped 60 sacks cement, pulled 11 jts. of tubing, couldn't tag cement, ran 11 jts. back in to 900', pumped 35 sacks cement and circulated out backside. Tagged cement @415', Log Tech perforated casing @300', pumped 40 sacks cement and circulated to surface. Topped off with 10 sacks cement. Used 60/40 pos, 4% gel.
