8 5/8" casing had been squeezed to surface. Perforated at 850' & 510'. Ran tubing to 2500' & pumped 100 sacks cement & 300# hulls. Pulled to 1200' & pumped 55 sacks cement & 200# hulls. Pulled tubing out & topped off with 10 sacks cement. Hooked up to 4 1/2" casing & pumped 5 sacks cement. Shut in psi-100#. Cut off 8 5/8" & 4 1/2" casings 4' below ground.
