Had log-tech perforate at 850' & 510'. Ran tubing to 2700' & pumped 100 sacks cement & 300# hulls. Pulled to 1200' & pumped 75 sacks cement & 200# hulls. Pulled tubing out & pumped 95 sacks cement down 4 1/2" casing. Circulated out of 8 5/8" casing. Cut 8 5/8" & 4 1/2" casings off 4' below ground.
