Plugged off bottom with sand to 3900' and 5 sacks cement. Cut casing loose @1990', pulled up to 800', pumped 15 sacks gel and 50 sacks cement, lost circulation. Ran in tubing to 800', pumped 50 sacks sacks cement, pulled up to 560', pumped 50 sacks cement, pulled up to 60' and circulated 20 sacks cement to surface. Tagged cement @180', circulated 40 sacks cement to surface. Plugging Complete.
