Cut casing loose @2624', pulled up to 1650', pumped 125 sacks cement and 200# hulls, pulled up to 1011', pumped 50 sacks cement and 100# hulls, pulled up to 565', pumped 50 sacks cement and 100# hulls, pulled up to 200' and circulated 75 sacks cement to surface.
