Plugged off bottom with sand to 5250' and 5 sacks cement. Cut casing loose @2830', pulled 10 ft., casing got stuck, cut loose @2500', pulled up to 1540'. pumped 15 sacks gel and 50 sacks cement, pulled up to 11550', pumped 50 sacks cement, pulled up to 520', pumped 30 sacks cement, pulled up to 40' and circulated 20 sacks to surface. Used 60/40 pos, 4% gel. Plugging Complete.
