Plugged off bottom with sand to 3550' and 5 sacks cement. Cut casing 8-5/8" from 5-1/2", 5-1/2" casing dropped to bottom of hole. Shot off 8-5/8" casing @1198' and layed down. Ran 2-7/8" tubing to 800', pumped 30 sacks gel and 100 sacks cement, pulled tubing up to 500', pumped 100 sacks cement, pulled up to 60' and circulated 50 sacks cement to surface. Plugging Complete.
