Spot additional 65 sks Class "C" cement to cover Anhydrite. Tag TOC @ X1510' .Cut & pull 5 1/2" casing from 1082', ( 25 jts csg ). Run tbg at 810' , mix & spot 75 sks Class"C" cement up to 533' , POH w/ tbg & top out 64' - 4' w/ 20 sks cement .
