Ripped casing at 2070'. Pulled casing up to 1250' & pumped 35 sacks cement, 3 % cc & 100# hulls. Pulled casing up to 700' & pumped 35 sacks cement, 3%cc & 100# hulls. Pulled casing up to 250' & pumped 190 sacks cement to surface.
