Dear Mr. Broadfoot:

Enclosed is a plugging record on the Sheldon #2 located in Section 7-14S-2W Saline County. I received a call that this disposal well stopped taking water. Initially we tried to clean out to the total depth of 3198. After encountering collapsed casing I called for you and you were out of the office. I explained to Mr. Brock our problem and he suggested I call Mr. Toman to be there the next time we tried to get past the collapsed casing.

On November 12 we tried again without success to get 2-3/8" tubing past the collapsed casing. Mr. Toman was there while this was taking place and supervised the entire plugging operation.

A driller's log is not available. A flood in 1951 apparently destroyed the records. The application for the disposal permit carried that notation.
